**GENERAL ORDINANCE NO. 16, 2012  
AS AMENDED**

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF TERRE HAUTE, INDIANA TO AMEND CHAPTER 9, ARTICLE 5 OF THE *TERRE HAUTE CITY CODE* TO CHANGE THE SEWER RATES AND CHARGES FOR USE OF AND SERVICES RENDERED BY THE SEWAGE WORKS.

SECTION 1. The *Terre Haute City Code*, Chapter 9, Article 5, Section 9-99 is hereby amended by deleting the stricken text and inserting the underlined text as follows:

**Sec. 9-99 Minimum Charges.**

The water usage schedule and the applicable sewage rates and charges based thereon shall be as follows as of the dates shown:

a. The rate for water used or sewage discharged shall be:

| <u>July 1, 2014</u>     | <u>Six Dollars and Forty Three Cents (\$6.43) per one hundred (100) cubic feet.</u>       |
| <u>July 1, 2015</u>     | <u>Seven Dollars and Forty Cents (\$7.40) per one hundred (100) cubic feet.</u>           |

b. The minimum charge (such minimum charge shall include the first three hundred (300) cubic feet of water usage) for any user per month or quarter according to the billing period shall be:

~~July 1, 2010~~ ~~Ten Dollars and Forty Nine Cents (\$10.49).~~

January 1, 2012 Fifteen Dollars and Twenty One Cents (\$15.21) except that in the event the user is not a metered water customer, the minimum charge shall be determined by means and methods satisfactory to the City.

July 1, 2013 Seventeen Dollars and Fifty Cents (\$17.50) except that in the event the user is not a metered water customer, the minimum charge shall be determined by means and methods satisfactory to the City.

July 1, 2014 Twenty Dollars and Thirteen Cents (\$20.13) except that in the event the user is not a metered water customer, the minimum charge shall be determined by means and methods satisfactory to the City.


July 1, 2015 Twenty Three Dollars and Sixteen Cents (\$23.16) except that in the event the user is not a metered water customer, the minimum charge shall be determined by means and methods satisfactory to the City.

c. All domestic non-commercial non-industrial users with non-metered water source shall pay a flat fee per month of:



SECTION 2. All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

SECTION 3. This Ordinance shall be in full force and effect on the date of its passage and any and all necessary approval by the Mayor of the City of Terre Haute.


